| | *While the bus is in motion, passengers must remain behind the driver's chair. |
| | *Please use the party pole in a safe manner by keeping feet on the floor |

DEPOSIT & PAYMENT & GRATUITY

A refundable deposit of \$150 is required to hold your date and serve as a security deposit for any damages. Please send or drop off your deposit check and contract within two days of confirming that you are making a reservation. The deposit check is separate from the payment/gratuity and will be returned as long as the contract is followed. Please make your check out to SCHUETZY'S LLC and mail or drop off at Schuetzy's Tavern, 18985 County Hwy J, Chippewa Falls, WI 54729

Full payment is due upon the time of pick-up. The full payment can be made in cash at the time of pickup, or by check. All prices include sales tax. A 20% voluntary driver gratuity would be an appropriate amount to give the driver.

DAMAGE POLICY & FEES

The driver inspects each vehicle before, during, and after each rental. In the event of damage, the customer shall be responsible for any repairs or cleaning. The following damages will result in automatic loss of your deposit as well as any damage NOT listed:

CANCELLATION
